I/We agree and understand that the payment procedure, interest assessment, if needed, as well as the collection process and procedure will be the same as described in the separate tuition contract for the above child. I/We understand and agree to assume full responsibility for the entire fee due as stated above, unless cancellation of this Agreement is made in writing. I/We understand and agree that the Extended Day Director shall retain the right to exclude any child from participating in any activity that, in his considered judgement, the child is not yet ready to participate in safely or where the child's participation at the time in question may interfere with the health or safety of others. I/We understand and agree that a Late Pick-Up Fee of one dollar (\$1.00) per minute is assessed for pick-ups after 5:00 PM or 6:00 PM based on the particular program the student is enrolled or pick-ups that are 30 minutes or more after the school has closed early due to inclement weather.

I/We have read the written materials prepared by The School that describe the program and understand the program is subject to change or cancellation at the discretion of The School at any time. I/We have read the above terms and conditions and fully understand and agree to abide by all the conditions and terms of this Agreement. This Agreement must be signed personally by both of the parents or guardians of the above named child, if applicable. Be certain to include the date when you sign this Agreement. This Agreement is not binding until signed and accepted by Barrie School.
